

Let's get into specifics, because I'm not sure that everything I recorded at <https://green4utah.vote/slushy-campaign-finances/> has been reviewed or investigated.

Specifically, Jordan Teuscher paid Candice Pierucci an unspecified amount with note "Conservative Millennial PAC Donation" through his Venmo account that was unreported by Teuscher, Pierucci, or the Conservative Millennial PAC. This transaction occurred TWO MONTHS before both candidates reported a \$1,500 donation from the Conservative Millennial PAC in each of their accounts.

- What is the amount from the July 7 transaction, and what is the source of these funds?
- Why is Teuscher transferring money to Pierucci (either for or on behalf of the Conservative Millennial PAC), two months in advance of receiving a PAC donation?
- Why is this transaction not recorded by Teuscher, Pierucci, or Conservative Millennial PAC at <https://disclosures.utah.gov/>?
- Was Teuscher advancing money expected from the PAC to Pierucci?
- Was Teuscher making a transfer of money on behalf of the Conservative Millennial PAC that went to Pierruci and was subsequently unreported?

On 07/07/2023, Jordan Teuscher paid Candice Pierucci an unspecified amount on Venmo with the note "**Conservative Millennial PAC Donation**". *This money does not show up in 2023 disclosure filings for Teuscher, Pierucci, or the Conservative Millennial PAC.*



If it was intended to be a donation, there is no mention of a donation to the **Conservative Millennial PAC** from either Teuscher or Pierucci before 09/16/2023.
