

# Summary of Issues

Jordan Teuscher (Utah Representative for House District 44) uses a personal Venmo account to receive campaign contributions, and to make campaign expenditures. The Venmo account activity is not limited to campaign related activity. The majority of transactions on his Venmo account @jordanteuscher are clearly personal in nature, which indicates this account is not (or should not be) tied to his separate campaign bank account. Teuscher appears to be co-mingling funds through his Venmo account in violation of Utah law.

Teuscher either knew or should have known that it is impermissible for a statewide candidate to co-mingle funds. Teuscher - who serves as the chairman of the House Committee on Ethics - should be versed in these regulations. It is troubling that Teuscher is looking to further weaken Utah campaign finance reporting laws with the introduction of HB160 in 2024.

Multiple campaign violations appear to occur in 2020, 2021, 2022 and 2023.

1. Two contributions received from **Erin Day** and **Jantsen Teuscher** through co-mingled Venmo account. There is no verification that the amount received is the same as the amount reported in disclosure.
2. Two contributions received from **Dr. Kelby Martin** and **Nathan Swiss** through co-mingled Venmo account. There is no verification that the amount received is the same as the amount reported in disclosure.
3. One contribution received from **Becki Robinson** through co-mingled Venmo account. There is no verification that the amount received is the same as the amount reported in disclosure.
4. One contribution received from **Lincoln Fillmore** through co-mingled Venmo account. There is no verification that the amount received is the same as the amount reported in disclosure.
5. Donation sent to **Amelia Powers Gardner** through co-mingled Venmo account.
6. Donation is not reported by **Amelia Powers Gardner** in her campaign's financial disclosure.
7. Donation sent to **Candice Pierruci** through co-mingled Venmo account.
8. Contribution received from **Amelia Powers Gardner** through co-mingled Venmo account.
9. Donation sent to **Amelia Powers Gardner**. Appears in Teuscher campaign report. We are unable to verify the source of funds because it is processed through a co-mingled Venmo account.
10. Reporting Issue: Gardner records donation from Teuscher (person) and not the Teuscher campaign. This is a noted discrepancy.
11. Teuscher pays **Salt Lake County Republican Party** for services through co-mingled Venmo account.
12. Teuscher pays **Vis-a-Vis Direct Mail** for services through co-mingled Venmo account.
13. One contribution received from **Becki Robinson** for "Peanuts and Cracker Jacks" through co-mingled Venmo account. \$36 recorded by Teuscher as a campaign donation.
14. Teuscher pays **Candice Pierruci** unspecified amount with note "Conservative Millennial PAC Donation" through co-mingled Venmo account two months before reporting a \$1,500 donation from the **Conservative Millennial PAC** in his own campaign disclosure.
15. The **Conservative Millennial PAC** discloses two \$1,500 donations (one to Teuscher on 9/15/2023, and one to Pierruci on 9/16/2023). It appears that Teuscher advanced money to Pierruci's campaign and was later reimbursed by the Conservative Millennial PAC.
16. Donation sent to **Candice Pierruci** through co-mingled Venmo account, later claimed to be a mis-reported payment for services using Pierruci as an intermediary.

On 3/9/2020, Jordan Teuscher reported a \$100 campaign contribution from Erin Teuscher (who later took the married name "Day"). On 3/12/2020 Jordan Teuscher received a contribution that reads "For you. And [political hat emoji]" from Jantsen Teuscher. On his campaign finance disclosures, Teuscher reported a \$100 contribution from Jantsen Teuscher on 3/13/2020.
